The CEO's leadership is required in the company's various economic development projects, including those aimed at increasing regional economic collaboration, improving export performance and attract direct domestic and foreign investment to Limpopo Province. CEO's key performance indicators include fulfilling the role of an effective Accounting Officer by providing effective leadership, efficient management and administration for MMSEZ to achieve its mandate and strategic goals. Forging and maintaining positive relationships with key stakeholders and partners. Providing executive support to MMSEZ Board and its committees.
